



Dear Teamsters Local 667 Retiree:

We are excited to announce a **NEW Group Medicare Plan** with prescription coverage that will be offered *exclusively* to all Teamsters Local 667 Medicare-eligible retirees, spouses, surviving spouses, and dependents. We have partnered with the professionals at Hancock-Hall Benefits (HHB) and TLC Insurance Group (TLC) to manage and service our Medicare-eligible retirees, including their exclusive access to the new Teamsters Local 667 Group Medicare plan. HHB/TLC's services are at *no cost to our members*. Our retirees will have access to their "TLC Retiree Service Center" which is very experienced in dealing with large national union and retiree groups.

The new Teamsters Local 667 Group Medicare plan also includes a **prescription drug benefit that is robust with low copays and has an open formulary. All Medicare approved drugs are covered.** With this new Group Medicare plan, many retirees may see a savings in overall out-of-pocket costs, especially on prescriptions, as compared to their current insurance. Additionally, this new Group Medicare plan allows members to access their *choice* of providers, anywhere in the U.S.

All current Medicare-eligible retirees will receive detailed communication and enrollment information in September. Please do not discard this information. Your savings could be substantial. *We encourage you to compare this exclusive group plan option and see the savings for yourself.* Whether you are turning 65 and new to Medicare or already enrolled in a plan, we encourage you to check out the new Teamsters Local 667 Group Medicare Plan and see if it is right for you and your family.
